#### 1. GENERAL INTRODUCTION

#### **Explanatory statement**

#### 2. JUSTIFICATION OF MAIN HEADINGS

#### 2.1 Revenue in 2008

The 2008 total revenue amounts to 43,160,000 and consists of a subsidy from the General Budget of the European Communities.

#### 2.2 Expenditure in 2008

The total forecasted expenditure is in balance with the total forecasted revenue.

#### Title 1 - Staff

The estimate of Title 1 costs is based on the assumption that the 44 posts mentioned in the 2008 Establishment Plan.

Total expenditure under Title 1 amounts to €4,868,000.

## Title 2 - Buildings, equipment and miscellaneous operating expenditure

Total expenditure under Title 2 amounts to €612,000.

#### Title 3 - Operational expenditure

Operational expenditure is entirely related to the implementation of the 2008 Work Programme and amounts to€2,680,000.
