

# DECISION No MB/2015/2 WP of the Management Board of the European Union Agency for Network and Information Security (ENISA) setting up a Permanent Stakeholders Group for the period 2015 - 2017

## THE MANAGEMENT BOARD OF ENISA,

Having regard to Regulation (EU) No 526/2013 of the European Parliament and of the Council of 21 May 2013 concerning the European Union Agency for Network and Information Security and repealing Regulation (EC) No 460/2004 and in particular Article 12 (1) thereof;

Having regard to the Decision No MB/2014/7 of the Management Board of European Union Agency for Network and Information Security (ENISA) on the Establishment and operation of the Permanent Stakeholders Group, and in particular Article 2 (4) thereof;

Whereas it is recommended that a multi-disciplinary group of experts shall be set up in order to provide an informed perspective and assist ENISA, in an advisory capacity, in the development of the Agency's work programme;

Whereas the Permanent Stakeholders Group shall be composed of representatives nominated by the Body of representative nominated by the Body of European Regulators for Electronic Communications<sup>1</sup>, a representative nominates by the Article 29 Data Protection Working Party<sup>2</sup> and a representative nominated by the European Police Office (Europol)<sup>3</sup> and recognised experts of private sector;

Whereas the Executive Director of the ENISA draw a proposal for nominating recognised experts in accordance with the procedure laid out in the Article 2 of the Decision No MB/2014/7 of the Management Board of European Union Agency for Network and Information Security (ENISA) on the Establishment and operation of the Permanent Stakeholders Group;
