

# DECISION No MB/2015/5 WP of the Management Board of the European Union Agency for Network and Information Security (ENISA) adopting Rules Implementing Staff Regulations

THE MANAGEMENT BOARD OF ENISA,

Having regard to Regulation (EU) No 526/2013 of the European Parliament and of the Council of 21 May 2013 concerning the European Union Agency for Network and Information Security and repealing Regulation (EC) No 460/2004 and in particular Article 5 (8) thereof.

Having regard to the Regulation No 31 (EEC), 11 (EAEC), laying down the Staff Regulations of Officials and Conditions of Employment of Other Servants of the European Economic Community and the European Atomic Energy Community ("Staff Regulations"), and in particular Article 110 thereof.

Having regard to the decisions of the European Commission setting up implementing rules for application of the Staff Regulations.

Whereas the Commission communicated to European Union Agency for Network and Information Security ("ENISA") that as Decision of the Management Board MB No. 2014/17 applying Commission Decision C(2013) 9045 taking effect as of 01/10/2014, does not apply without Commission Decision C(2009) 10224, ENISA has decided to apply by analogy both Commission Decisions of 2009 and 2013 (amending 2009's).

Whereas the Staff Regulations provides that implementing rules shall enter into force at the agencies nine months after their entry into force at the European Commission or nine months after the date on which the European Commission informed the agencies of the adoption of the respective implementing rule (in this case 26/09/2014). Accordingly, the latest date for implementation at ENISA is 25/06/2015.

Whereas the Staff Committee ENISA has been consulted.

Whereas the ENISA Executive Board scrutinised the draft decision of the Management Board of ENISA adopting Rules Implementing Staff Regulations on Teleworking.

HAS ADOPTED THIS DECISION:

# Article 1

The Commission Decision C(2009) 10224 concerning the implementation of teleworking in Commission departments from 2010 to 2015, as adopted by the European Commission on  $18^{th}$  December 2009 which entered into force on  $01^{st}$  January 2010 and Commission Decision C(2013) 9045 final, amending Article 7(5) and (7) of Commission Decision C(2009) 10224 as adopted by the European Commission on  $16^{th}$  December 2013 which entered into force at ENISA on  $01^{st}$  October 2014 by means of MB Decision No MB/2014/17 and listed in Annex I, shall apply by analogy to the staff of ENISA.



## Article 2

A Notice of Interpretation is attached to this Management Board Decision.

#### Article 3

Commission Decision C(2009) 10224 and Commission Decision C(2013) 9045 amending Art. 7(5) and (7) of Commission Decision C(2009) 10224 shall take effect on the date that this Decision enters into force.

## Article 4

This Decision shall enter into force on the date of its signature.
