# DECISION NO MB/2020/19 OF THE MANAGEMENT BOARD OF THE EUROPEAN UNION AGENCY FOR CYBERSECURITY

# ADOPTING DATES IN 2021 FOR MEETINGS OF THE BODIES REFERRED TO IN ARTICLE 13 OF THE CYBERSECURTIY ACT

THE MANAGEMENT BOARD OF ENISA.

**Having regard to** Regulation (EU) (EU) 2019/881 of the European Parliament and of the Council of 17 April 2019 on ENISA (the European Union Agency for Cybersecurity) and on information and communications technology cybersecurity certification and repealing Regulation (EU) No 526/2013 (Cybersecurity Act), in particular Article 17(2);

Having regard to the Decision No MB/2020/4 setting up National Liaison Officers Network

Having regard to the Decision No MB/2020/2 on the Establishment and Operation of the Advisory Group

**Having regard to** the Decision No MB/2013/9 of the Management Board of the European Union Agency for Cybersecurity (ENISA) on internal procedure for the Management Board of ENISA and for the Executive Board of ENISA, in particular Article 3

### **Whereas**

- The Management Board of ENISA shall hold an ordinary meeting at least twice a year and the
  extraordinary meetings at the request of the Chairpeson, at the request of the Commission or at the
  request of at least one third of the members with a right to vote.
- 2. A timely planning of the meetings of ENISA statutory bodies is crucial for several processes within the Agency, in particular for the development of a single programming document and the statement of estimates and their implementation.
- 3. The Management Board has several statutory deadlines for its decisions, namely 1<sup>st</sup> July and 30th November and these deadlines are interlinked with the processes other bodies of the Article 13 of the Cybersecurity Act are contributing to.
- 4. The Chairperson of the National Liaison Officers Network and the Chairperson of the Advisory Group has been consulted.
- 5. The Executive Board scrutinised this decision at its meeting held on 22 -23 October 2020.

- 2. Should the majority of the Executive Board members request an additional meeting, the date should be selected by the Executive Board after consulting with the ENISA Management Board secretariat.
