DECISION NO MB/2022/03

OF THE MANAGEMENT BOARD OF THE EUROPEAN UNION AGENCY FOR CYBERSECURITY (ENISA) ON THE APPOINTMENT OF REPORTING OFFICERS FOR THE APPRAISAL EXERCISE OF THE EXECUTIVE DIRECTOR

THE MANAGEMENT BOARD OF ENISA;

Having regard to Regulation (EU) 2019/881 of the European Parliament and of the Council of 17 April 2019 on ENISA (the European Union Agency for Cybersecurity) and on information and communications technology cybersecurity certification and repealing Regulation (EU) No 526/2013 (Cybersecurity Act)¹ (hereinafter referred to as the 'ENISA Regulation'), and in particular Article 15(1), points (m) and (n), and Article 36(1) thereof,

Having regard to MB Decision No MB/2022/02 concerning the probationary period, the management trial period and the annual appraisal of the Executive Director of the European Union Agency for Cybersecurity,

Having regard to the Staff Regulations of Officials ('Staff Regulations') and the Conditions of Employment of Other Servants ('CEOS') of the European Union, laid down by Council Regulation (EEC, Euratom, ECSC) No 259/68², and in particular Articles 43, 44 and 46 of the Staff Regulations and Articles 14, 15 and 20 of the CEOS,

Having regard to the Commission's Decision³ giving its agreement pursuant to Article 110(2) of the Staff Regulations,

Whereas:

- 1) The Executive Director of the European Union Agency for Cybersecurity shall be subject to an annual appraisal exercise, organised at the beginning of each calendar year.
- 2) On 15 October, 2019 the Management Board appointed two names from among the members of the Management Board for the probational period and for the subsequent appraisal exercise.
- 3) The framework model provided by the Commission services requires three reporting officers.
- 4) The Executive Board discussed the matter on 21 October, 2021 and on 20 January, 2022

HAS DECIDED AS FOLLOWS:

Single Article

The representative of the European Commission in the Management Board *Mrs Lorena Boix-Alonso*, the representative from Poland *Mr Krzystof Silicki*, and the representative from Netherlands *Mr Hans de Vries* are appointed reporting officers for the annual appraisal exercises of the Executive Director for the years 2020 and 2021.
