

# DECISION No MB/2017/9 of the Management Board of the European Union Agency for Network and Information Security (ENISA) setting up a Permanent Stakeholders' Group for the period of 2017-2020

# THE MANAGEMENT BOARD OF ENISA,

Having regard to Regulation (EU) No 526/2013 of the European Parliament and of the Council of 21 May 2013 concerning the European Union Agency for Network and Information Security (ENISA) and repealing Regulation (EC) No 460/2004, in particular Article 12(1) thereof;

Having regard to Decision No MB/2014/7 of the Management Board of the European Union Agency for Network and Information Security (ENISA) on the Establishment and Operation of the Permanent Stakeholders' Group, in particular Article 2(4) thereof;

Whereas it is recommended that a multi-disciplinary group of experts be set up in order to provide an informed perspective and assist the European Union Agency for Network and Information Security (ENISA), in an advisory capacity, in the development of the Agency's Single Programming Document.

Whereas the Permanent Stakeholders' Group shall be composed of:

- a. recognised experts of private sector, namely, from information and communication technology (ICT) industry or providers of the electronic communications networks or services available to the public; consumer groups; academia experts in network and information security, and
- b. a representative nominated by the Body of European Regulators for Electronic Communications<sup>1</sup>, a representative nominated by the Article 29 Data Protection Working Party<sup>2</sup>, and a representative nominated by the European Police Office (Europol)<sup>3</sup>.

Whereas the Executive Director of the European Union Agency for Network and Information Security (ENISA) selects and proposes to the Management Board the nomination of recognised experts in accordance with the procedure laid out in Article 2 of the Decision No MB/2014/7 of the Management Board of ENISA on the establishment and operation of the Permanent Stakeholders' Group;

### Article 3

The persons identified in Article 1 are hereby appointed "ad personam" as members of the Permanent Stakeholders' Group for a term of 2,5 years, which shall run from 24 October 2017 to 24 April 2020.

# Article 4

Where it is necessary to replace the appointees of the Permanent Stakeholders' Group, the Executive Director of the European Union Agency for Network and Information Security (ENISA) shall have the discretion to select a name from the reserve list who belongs to the same sector as the person who previously occupied the vacant position on the Permanent Stakeholders' Group. The selected person shall hold the position on the Permanent Stakeholder's Group for the remainder of its term of establishment.

### Article 5

This Decision shall enter into force on the date of its signature.
