NIS DIRECTIVE

- IMPLEMENTATION OF NIS DIRECTIVE IN THE FORM OF A NEW LAW APPROVED BY CABINET
- EXPECTED DATE OF IMPLEMENTATION JANUARY 2020
- PREPARATION FOR CSIRT ROLE PLANNED 2019
- PLANNING AND PREPARING FOR NIS IMPLEMENTATION

FIRST

- Revision of standard operational procedures and operations in conjunction with FIRST application
- Successful site visit by FIRST representatives conducted in December 2018

CERT.IS CONSTITUENCY

- CONSTITUENCY EXPANDED 2018 TO INCLUDE THE GOVERNMENT MINISTRIES
- TELECOMMUNICATIONS PROVIDERS ALONG WITH MINISTRIES ARE NOW THE FORMAL CONSTITUENCY
- ADDITIONALLY, NATIONAL POINT OF CONTACT WITH THE ASSOCIATED DUTIES
- Foreseen ongoing relations with other CI sectors in preparation for NIS
