(Czech Republic, Sweden, Switzerland, Latvia, Austria, Luxemburg not through NLOs)

- NCSS working group: 8 member states Belgium, Lithuania, Hungary, Austria, Estonia, Slovakia, France, Portugal (evaluation of national Cyber-security strategies)
- ECSM project: 20 member states (estimation) instrumental support in 2014 (as in 2013)

** enisa Collaboration actions 3

- Information request on the state of play of European National Public-Private Partnerships (PPPs)
 - 5 countries BE, DK, DE, NL, SE
- Responded to survey on ICT security and privacy requirements when procuring cloud computing services per country (11 countries)
- Further disseminated the info on ENISA events e.g.
 Secure Cloud 2014

- EU FI-ISAC: request for new members. ENISA the intermediary putting interested MS in contact with chairman. LU and FR (tentatively)
