DATA PROTECTION NOTICE

ENISA VALIDATION WORKSHOP: SUPPORTING THE DEPLOYMENT OF THE EU CYBERSECURITY CERTIFICATION FRAMEWORK

The European Union Agency for Cybersecurity (ENISA) process your personal data to organise and manage a workshop on ENISA activities in cybersecurity certification which will take place on 5 December 2019 in Brussels.

Your personal data shall be processed in accordance with the Regulation (EU) 2018/1725 on the protection of natural persons with regard to the processing of personal data by the Union institutions, bodies, offices and agencies and on the free movement of such data.¹

The data controller of the processing operation is ENISA - Core Operations Department.

The legal basis for the processing operations is article 5(1)(a) of Regulation (EU) 2018/1725, on the basis of Regulation (EU) 2019/881 (Cybersecurity Act), especially the provisions establishing the tasks of ENISA.

The purpose of the processing of your personal data is: handling invitations and participation requests, reporting on the event, as well as event follow-up actions, such as sharing presentations among participants and feedback collection.

The following personal data are processed:

- · Contact data, such as first name, last name, title (optional), function (optional), organisation, e-mail
- Financial data related to the reimbursement of expenses of invited participants.

The recipients of your data will be designated ENISA staff involved in the organisation of the conference, designated staff of ENISA's contractors involved in the event, and bodies charged with monitoring or inspection tasks in application of EU law (e.g. internal audits, European Anti-fraud Office – OLAF).

The final participants list (name, surname, organisation, country) will be kept by ENISA for a maximum period of 5 years after the end of the event for auditing purposes.

Your contact data will be kept for a maximum period of six months after the end of the event and in any case no later than 10 working days after the last event's follow-up action.

Financial data related to the event will be kept by ENISA for a maximum period of 10 years after the end of the event for auditing purposes. All data will be deleted after the end of their respective retention periods.

You have the right of access to your personal data and to relevant information concerning how we use it. You have the right to rectify your personal data. Under certain conditions, you have the right to ask that we delete your personal data or restrict its use. You have the right to object to our processing of your personal data, on grounds relating to your particular situation, at any time. We will consider your request, take a decision and communicate it to you. For more information, please see articles 14 to 21, 23 and 24 of Regulation (EU) 2018/1725.
