DATA PROTECTION NOTICE - ENISA/BEREC WORKSHOP

PRIVACY STATEMENT

The European Union Agency for Cybersecurity (ENISA) and the Body of European Regulators for Electronic Communications (BEREC) process your personal data to organise and manage the joint ENISA/BEREC Workshop titled Implementing the EU 5G toolbox across the digital single market on 27 March 2020 in Brussels.

Your personal data shall be processed in accordance with the Regulation (EU) 2018/1725 on the protection of natural persons with regard to the processing of personal data by the Union institutions, bodies, offices and agencies and on the free movement of such data¹.

The joint data controllers are ENISA and BEREC, who are jointly responsible for the overall organisation of the event, the communication with the participants before and after the end of the event. **ENISA** is also responsible for the online registration of the event's participants through its website.

The **data processor** is EaudeWeb SRL., which provides the hosting of ENISA web site and other relevant services. Moreover, T&T event organiser supports ENISA with regard to travel arrangements for invited speakers, logistics, catering, and registration at the event.

The legal basis for the processing operation is article 5(1)(a) of Regulation (EU) 2018/1725, on the basis of Regulation (EU) 2019/881 for ENISA and Regulation (EU) 2018/1971 for BEREC, in particular the provisions establishing the tasks of ENISA and BEREC accordingly.

The purpose of the processing of your personal data is: handling invitations and participation requests, reporting on the event, as well as event follow-up actions, such as sharing presentations among participants and feedback collection.

The following personal data are collected (upon registration to the event): Contact data, such as first name, last name, title (optional), function (optional), organisation, e-mail, country

Please note that photos will be taken during the workshop, based on the prior consent of the speakers. These photos may be published on ENISA's and BEREC's websites and/or relevant social media channels. The focus of the photos will be on the speakers only and not on general views of the audience or specific views/pictures of workshop's participants (other than speakers).

Your contact data will be kept for a maximum period of six months after the end of the event. All data will be deleted after the end of their respective retention periods.

Under certain conditions, you have the right to ask that we delete your personal data or restrict its use. You have the right to object to our processing of your personal data, on grounds relating to your particular situation, at any time.
