PRIVACY STATEMENT – MEP BREAKFAST ON CYBERSECURITY

The joint data controllers for the processing operation in subject are ENISA (Core Operations Department) and the Representation of the Free State of Bavaria to the European Union. The joint controllers share responsibility for the overall organisation of the event, and the communication with the participants before and after the event. ENISA is responsible for the registration of invited participants.

ENISA processes your personal data in accordance with Regulation (EU) 2018/1725 on the protection of natural persons with regard to the processing of personal data by the Union institutions, bodies, offices and agencies and on the free movement of such data.¹ The legal basis for the processing operation in subject is Article 5(1)(a) of Regulation (EU) 2018/1725 in conjunction with the ENISA Founding Regulation (EU) 526/2013.²

The Representation of the Free State of Bavaria to the European Union processes your personal data in accordance with the Regulation (EU) 2016/679 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data (General Data Protection Regulation – GDPR).³ The legal basis for the processing operation in subject is (Article 4 (1) Bayerisches Datenschutzgesetz – BayDSG in conjunction with Article 6 (1) letter e in conjunction with Article 6 (3) page 1 General Data Protection Regulation – GDPR).

The purpose of this processing operation is to:

- Register interested persons to the MEP Breakfast that will take place at the Representation of the Free State of Bavaria to the European Union on 24 September 2019;
- 2. Provide access to the event venue;
- 3. Include the invited participants in the list of participants;
- 4. To allow event follow-up actions, such as sharing presentations among participants and feedback collection.

The following personal data are collected:

- Contact data: such as first name, last name, title, function, organisation, country, e-mail address, phone number, etc.
- Data on dietary preferences.

The recipients of your data will be designated staff of ENISA and the Representation of the Free State of Bavaria to the European Union involved in the organisation of the event, as well as relevant event organisers contracted by the organisers that process the personal data on behalf of the joint data controllers. Access may also be granted to the bodies charged with monitoring or inspection tasks in application of EU law (e.g. internal audits, European Anti-fraud Office – OLAF).

The final participants list (name, surname, organisation, country) will be kept for a maximum period of 5 years after the end of the event for auditing purposes. Your contact data will be kept for a maximum period of six months after the end of the event for communication/follow-up of the event. Data on dietary preferences will be kept only until the completion of the event. Data will be deleted at the end of the aforementioned periods.

You have the right of access to your personal data and to relevant information concerning how we use it. You have the right to rectify your personal data. Under certain conditions, you have the right to ask that we delete your personal data or restrict its use. You have the right to object to our processing of your personal data, on grounds relating to your particular situation, at any time. We will consider your request, take a decision and communicate it to you.
