

# DATA PROTECTION NOTICE

## TRUST SERVICES FORUM AND CA DAY 2021

ENISA Trust Services Forum and the CA-Day are two consecutive events organised by the European Union Agency for Cybersecurity (ENISA) and D-TRUST (a company of the Bundesdruckerei group) respectively that will take place online on the 21st and 22nd of September 2021. The virtual organisation of both events is supported by an online teleconference platform (Zoom) provided by co-organizer of the event, the Digital Society Institute Berlin at European School of Management and Technology GmbH (ESMT/DSI).

**The joint data controllers** for the processing of your personal data in the context of this event are both ENISA (Policy Development and Implementation Unit) and D-TRUST.

**ENISA and D-TRUST are both responsible** for the overall organisation of the events as well as the communication with the participants before and after the end of the event. ENISA will maintain and manage the web page for the online registration of the participants for both events. The Zoom teleconference platform will be managed by **ESMT/DSI**.

**ENISA processes personal data** in accordance with the Regulation (EU) 2018/1725<sup>1</sup> on the protection of natural persons with regard to the processing of personal data by the Union institutions, bodies, offices and agencies and on the free movement of such data.

**The legal basis** for the processing operation is article 5(1)(a) of Regulation (EU) 2018/1725, on the basis of Regulation (EU) No 881/2019, in particular the provisions establishing the tasks of ENISA.

**D-TRUST processes personal data** in accordance with the new Federal Data Protection Act (Bundesdatenschutzgesetz, BDSG (new)), and the EU Regulation 2016/679 of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data<sup>2</sup>. The legal basis for the processing of data are Articles 6(a) and 6(b) of EU Regulation 2016/679.

**The purpose** of the processing of personal data is to organise the online events, register the event's participants through ENISA's website, provide registered participants' access to the virtual sessions through the teleconference platform, as well as communicate with the registered participants within the scope of the Trust Service Forum and CA Day 2021.

**The following personal data are processed for the events' participants:** first name, last name, organisation and email address (collected upon registration at ENISA's website).

**Recipients of personal data:** access to your contact data is granted only to designated ENISA and D-TRUST staff, who are involved in the organisation of both events. Access to the personal data may be

provided to EU bodies charged with monitoring or inspection tasks in application of national or EU law (e.g. internal audits, European Anti-fraud Office – OLAF).

ESMT/DSI will process the connection details for virtual session through the Zoom platform in order to provide for the event. Information about the Zoom GDPR compliance you can find here: <https://zoom.us/gdpr>.

**The retention periods** for the personal data are as follows: the participants' contact data will be kept by ENISA for a maximum period of 6 months after the end of events, unless the participants have provided their consent upon registration for further processing by ENISA and/or D-TRUST (in order for the participants to get informed about future activities and events). In the latter case, ENISA will keep the contact data until the participants withdraw their consent<sup>3</sup>. Personal data will be deleted after the end of the retention periods.

**Storage of personal data:** the contact data collected upon registration at the ENISA website are stored on the ENISA's servers and are only processed within EU/EEA.

**You have the right** of access to your personal data and to relevant information concerning how we use it. You have the right to rectify your personal data. Under certain conditions, you have the right to ask that we delete your personal data or restrict its use. You have the right to object to our processing of your personal data, on grounds relating to your particular situation, at any time. We will consider your request, take a decision and communicate it to you.
