DATA PROTECTION NOTICE

10TH ENISA eHEALTH SECURITY CONFERENCE

The 10th eHealth Security Conference is organized by the European Union Agency for Cybersecurity (ENISA). The event will take place in a physical format on September 16th, 2025 in Bucharest.

Your personal data in the context of the 10th eHealth Security Conference shall be processed in accordance with the Regulation (EU) 2018/1725 on the protection of natural persons with regard to the processing of personal data by the Union institutions, bodies, offices and agencies and on the free movement of such data¹ and Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data².

The purpose of the processing is to facilitate the organisation of the conference and registration of interested individuals, provide access to the conference venue as well as allow communication prior to and after the conference, including feedback collection.

The joint data controllers for the processing of your personal data in the context of this event are: the European Union Agency for Cybersecurity (ENISA), Resilience of Critical Sectors (ROCS) Unit, the Romanian National Directorate for Cybersecurity (DNSC-RO) and the European Cybersecurity Competence Centre (ECCC).

ENISA is responsible for the overall organisation of the event as well as the communication with the participants before and after the conference. .

The **ECCC** and **DNSC-RO** are responsible for organization of the event and facilitate access of registered participants.

The legal basis for the processing operation is article 5(1)(a) of Regulation (EU) 2018/1725, on the basis of Regulation (EU) No 2019/991, in particular the provisions establishing the tasks of ENISA and on the basis of Regulation (EU) No 2021/887, in particular the provisions establishing the tasks of the ECCC and article 6(1)(e) of Regulation (EU) 2016/679{GDPR for DNSC-RO.

The data processors involved in the processing operation are:

- Microsoft Azure providing cloud hosting services for ENISA website under a framework contract with the European Commission (Cloud II) to which ENISA is a party;
- Bilbomatica S.A and its subcontractor Syslab GmbH providing web development and web hosting maintenance services under a contract with ENISA.

The following personal data is processed for the events' participants:

- Contact data: first name, last name, organisation, role, country and email address

Please Note:

- 10th eHealth Security Conference will not be audio/video recorded.
- There will be photos taken during the workshop's presentations (keynotes/panels) based on the prior consent of the speakers (presenters/panel participants). These photos may be published on ENISA's website and/or relevant social media channels. The focus of the photos will be on the speakers and on general views of the audience. Specific views/pictures of conference's participants (other than speakers) will not be taken. Still, should your photo be taken in the context of this photo shooting, and you would like to have this photo removed, please contact ENISA at eHealthSecurity@enisa.europa.eu and we will do so as soon as possible.

The retention periods for the personal data are as follows: the participants' contact data will be kept for a maximum period of 6 months after the end of the event, unless the participants have provided their consent upon registration for further processing by ENISA (in order for the participants to get informed about future ENISA activities and events). In the latter case, ENISA will keep the contact data until the participants withdraw their consent³. The **signed participants list** (name, surname, organisation, country) **will be kept** for a maximum period of 5 years after the end of the event for auditing purposes. **Financial data** related to the conference will be kept for a maximum period of 7 years after the end of the event for auditing purposes.

Recipients of personal data: access to your contact data is granted only to designated ENISA, DNSC-RO and ECCC staff, who are involved in the organisation of the event. Access to the personal data may be provided to EU bodies charged with monitoring or inspection tasks in application of national or EU law (e.g. internal audits).

You have the right of access to your personal data and to relevant information concerning how we use it. You have the right to rectify your personal data. Under certain conditions, you have the right to ask that we delete your personal data or restrict its use. You have the right to object to our processing of your personal data, on grounds relating to your particular situation, at any time. We will consider your request, take a decision and communicate it to you. If you have any queries concerning the processing of your personal data, you may address them to ENISA at eHealthSecurity@enisa.europa.eu. You may also contact at any time the ENISA DPO at dataprotection@enisa.europa.eu, the ECCC DPO at data-protection@eccc.europa.eu and DNSC-RO DPO at {email}.
