

# DATA PROTECTION NOTICE

## 6<sup>TH</sup> ENISA TELECOM AND DIGITAL INFRASTRUCTURE SECURITY FORUM

The European Union Agency for Cybersecurity (ENISA) and the Digital Security Authority of Cyprus (DSA) are co-organizing the **6<sup>th</sup> edition of the Telecom and Digital Infrastructure Security Forum together with the Cyprus Presidency of the Council of the EU**. The conference will take place on the 20<sup>th</sup> of March 2026 in Paphos, Cyprus.

This notice explains how your personal data will be processed in the context of the participation in the 6<sup>th</sup> edition of the Telecom Forum. **Your personal data** shall be processed in accordance with:

- Regulation (EU) 2018/1725 of the European Parliament and of the Council of 23 October 2018 on the protection of natural persons with regard to the processing of personal data by the Union institutions, bodies, offices and agencies and on the free movement of such data, and repealing Regulation (EC) No 45/2001 and Decision No 1247/2002/EC<sup>1</sup>
- Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (GDPR)<sup>2</sup>.

**The processing of your personal data shall be carried out by** ENISA, Resilience of Critical Sectors Unit (RoCS) and the the Digital Security Authority of Cyprus (DSA) - **Secretariat of the Cyprus Presidency of the Council of the EU 2026** who are **the joint data controllers** of this processing operation.

**ENISA is responsible** for shaping the event's agenda, promoting the event (both before and after), making conference material available online and follow up of the conference with registered participants.

**The Digital Security Authority of Cyprus (DSA) - Secretariat of the Cyprus Presidency of the Council of the EU 2026 is responsible** for shaping the event's agenda, promoting the event (both before and after), offering the venue and catering services, managing registrations, facilitating access of registered participants to the venue and follow up of the conference with registered participants.

**The legal basis** for the processing operation is:

- article 5(1)(a) of Regulation (EU) 2018/1725 on the basis of Regulation (EU) 2019/881 (Cybersecurity Act), in particular the provisions establishing the tasks of ENISA and
- article 6(1)(e) of Regulation (EU) 2016/679 for DSA.

**The legal basis for the recording of presentations, panel discussions, taking pictures and making them publicly** available is:

- article 5(1)(d) of Regulation (EU) 2018/1725 for ENISA and
- article 6(1)(a) of Regulation (EU) 2016/679 for DSA.

**The purpose** of this processing operation is to facilitate the registration and participations to the ENISA Telecom and Digital Infrastructure Forum and any related communication activities before and after the event, including feedback collection, sharing conference material among participants and making publicly available pictures from the conference (for the speakers and participants who have provided their consent).

**The data processors** for this processing operation are:

- EC DG DIGIT, under an SLA with ENISA, providing hosting services.
- Unisystems S.A. (<https://www.unisystems.com/>) and Eau De Web (<https://eaudeweb.ro/>) providing web development, support and maintenance services under a Framework Contract with ENISA.
- Cloudflare (<https://cloudflare.com>) providing protection against Denial of Service (DDos) attacks to the ENISA's website. The service has been acquired via the European Commission's SIDE III Framework Contract.
- Awapai Ltd registered in Athens, Greece, operating the Eventora platform, under a contract with DSA, used for follow up registration of participants; the relevant privacy policy/record is available under <https://www.eventora.com/en/Terms>.

**The following personal data being processed** are:

- First name, Last name email, position, organisation, country;
- Phone (optional);
- Special Requirements/Dietary Restrictions/Preferences;
- consent to being photographed / recorded and authorize the use of this material on institutional websites social media for communication purpose (mandatory)

**Access to your data** will be granted only on a need-to-know basis to ENISA and DSA- Secretariat of the Cyprus Presidency of the Council of the EU 2026 staff members supporting the organisation of the conference and the relevant contractors referred to herein above. The data may also be available to EU bodies charged with monitoring or inspection tasks in application of EU law (e.g. internal audits, European Anti-fraud Office – OLAF).

**Personal data will be retained** for a duration of 1 month following the conclusion of the event for ENISA and for the duration of the Presidency for the Secretariat of the Cyprus Presidency of the Council of the EU 2026.

The signed participants list (name, surname, organisation, country) will be kept by ENISA for a maximum period of 5 years after the end of the event for auditing purposes and by the DSA for a period of 3 months after the end of the event for feedback collection purposes.

**Personal data are not transferred** outside the European Union or the European Economic Area. If a transfer becomes necessary, it will take place in accordance with the applicable data protection rules and appropriate safeguards.

**You have the right** of access to your personal data and to relevant information concerning how it is used. You have the right to rectify your personal data. Under certain conditions, you have the right to ask for the deletion of your personal data or the restriction of its use. You have the right to object to the processing of your personal data, on grounds relating to your particular situation, at any time. In all cases, your request will be considered and a decision will be taken and communicated to you.
