




Number of active qualified trust service providers (QTSPs) per type.

Breakdown per type of qualified trust services. There are 9 types of qualified trust services, as defined in the Regulation n°910/2014 (the "eIDAS" Regulation). These types are:

- Qualified certificate for electronic signatures
- Qualified certificate for electronic seals
- Qualified certificate for web site authentication
- Qualified validation of qualified electronic signatures
- Qualified validation of qualified electronic seals
- Qualified preservation of qualified electronic signatures
- Qualified preservation of qualified electronic seals
- Qualified electronic time stamps
- Qualified electronic registered delivery



The elDAS review – state of play

• Article 49

The Commission shall review the application of this Regulation and shall report to the European Parliament and to the Council no later than 1 July 2020.

- Strategy for Digital Europe
 Commission announced for Q4 a revision of the elDAS
 Regulation
- In June 2020 TTE Council Conlusions "Shaping Europe's Digital Future" call for a European Digital Identity, which is widely usable, secure and interoperable for secure government and private online transactions
- Evaluation of the elDAS framework (Evaluation study of the elDAS Regulation)
- Study to support the impact assessment
- Extensive contact with stakeholders





"Every time an App or website asks us to create a new digital identity or to easily log on via a big platform, we have no idea what happens to our data in reality. That is why the Commission will soon propose a secure European e-identity. One that we trust and that any citizen can use anywhere in Europe to do anything from paying your taxes to renting a bicycle. A technology where we can control ourselves what data and how data is used."

"Modernise - EU-ID and key digital public services should be modernised and accessible to all. Secure and EU-wide electronic identification and authentication visà-vis governments and private actors and access to their services, will provide citizens with control over their online identity and data as well as enable access to online digital services. The digitalisation of public administration and services will increase the effectiveness of both. This includes also the justice and healthcare system. By 2025, Member States should ensure the provision of a European digital identity (e-ID) and public administrations should be providing interoperable, personalised and userfriendly digital public services."



Mission

Examine the relevant issues and make recommendations for minimum standards which could be accepted jointly by EU institutions, bodies and agencies. These recommendations must be consistent with existing EU legislative frameworks, and strive to find an appropriate balance between efficiency and ease of use, costs and legal and other risks.





Connecting Europe Facility (CEF) programme
