PRIVACY STATEMENT IDENTIFICATION OF MINIMUM SECURITY MEASURES IN THE ENERGY SECTOR

Your personal data are processed in accordance with Regulation (EC) (EU) 2018/1725 ¹ on the protection of natural persons with regard to the processing of personal data by the Union institutions, bodies, offices and agencies and on the free movement of such data.

The data controller of the processing operation is ENISA (Core Operations Department).

The data processor of the processing operation is Laborelec S.A which is responsible for collecting and analysing the replies to the survey.

The legal basis for the processing operation is: i) Article 5(1) (a) of Regulation (EU) 2018/1725, on the basis of Regulation (EU) 2019/881², in particular the provisions establishing the tasks of ENISA, and ii) Article 5(1) (d) of Regulation (EU) 2018/1725– consent of data subjects.

The purpose of this processing operation is to collect experts' views on the subject matter of the survey.

The following personal data are being processed:

- Contact data: first name, last name, role, type of organisation, country, e-mail address.
- Replies to the survey questions (i.e. survey data) which do not contain personal data, except from personal data provided on ad hoc basis by the respondents.

The recipients of your data will be designated ENISA staff involved in the conduction of the survey, as well as designated personnel of the data processor. The data may also be available to EU bodies charged with monitoring or inspection tasks in application of EU law (e.g. internal audits, European Antifraud Office – OLAF).

Your contact data will be kept for a maximum period of six months after the end of the project. **The replies to the survey questions** will be kept (without your contact data) for a maximum period of 5
